

## **2023 Orchard Valley Golf Club Annual Pass Agreement**

### **Eligibility**

At the discretion of the Management of Orchard Valley, the Annual Passes are available without discriminatory regard to race, gender, creed, religion or national origin. Prospective members must complete an application and acknowledge all terms, policies and conditions contained herein. The management of Orchard Valley Golf Club reserves the right to cancel or amend this offer at any time without notice. The management reserves the right to revoke this membership if a pass holder violates the Annual Pass Guidelines.

### **Terms & Renewal**

Unlimited golf privileges associated with The Annual Pass are valid through 12/31/2023 – All Pass Holders are recommended to have a Credit Card on File with the Golf Shop. Unlimited golf privileges outlined in the Annual Pass documents do not extend to tournament play, special events or outside league play. Accompanied guests shall pay the regular current OVGC rates. Pass holders will also receive (2) small range buckets per day (equivalent to 1 medium bucket). Additionally, Annual Pass Holders will receive 10% off all in-stock Golf Shop Merchandise.

### **Reservations & Cancellations**

Starting times may be reserved up to thirty (30) days in advance. Any Tee Times that are not cancelled within a 24-Hour timeframe will be charged the public rate for the missed time.

### **Registration**

To maintain the integrity of play administration, all Annual Pass Holders are required to make a tee time and MUST CHECK-IN the golf shop prior to beginning play. All play will begin from the #1 tee box.

### **Pace of Play**

Players are required to always keep pace with the group in front of them and/or complete 18 Holes at a pace of 4 hours and 20 minutes.

### **Golf Cart Policy**

Golf Cart is included with the Annual Pass, unless otherwise noted. Generally, golf carts are not restricted to the paths at OVGC. However, inclement weather or other conditions may occasionally necessitate the need to do so. This decision made entirely at the discretion of OVGC Staff and may be made without forewarning. Pass Holders are financially responsible for any damages incurred during their round.

### **Course Availability**

OVGC Management reserves the right to host special events and/or golf outings that will limit course availability throughout the year. In most cases, the Golf Shop can inform you of these instances up to 30 days in advance. Weekday Only and Senior Annual Pass (Weekday Only) are not Valid on Saturday & Sunday.

### **Dress Code**

Orchard Valley Golf Club is a non-metal spike facility. Men must wear shirts with a collar and sleeves at all times. Ladies may wear a polo with collar and or sleeves. T-shirts, tank-tops, halter-tops, and swimwear are not allowed at any time. Denim is also not permitted at OVGC.

## Transfers & Revocations

The privileges provided to Annual Pass Holders are personal to the card holder and may not be sold, transferred or assigned in any manner. Privileges shall cease and terminate upon the passing of the card holder. Any fees paid are to be non-refundable. The management of OVGC reserves the right immediately revoke membership and its' privileges if a card holder is found to have violated the terms herein. No portion of any fees paid is refundable upon revocation.

## ORCHARD VALLEY GOLF CLUB MANAGEMENT

Policies and procedures are established and administered by the management of OVGC, including but not limited to the General Manager, Head Golf Professional, Golf Shop Managers and any others so designated by the club. Annual Pass in no way conveys rights of ownership and its privileges outlined in this document are subject to change at any time by ownership of the club in its sole discretion.

The Undersigned hereby agrees that the information contained within this document is completely accurate and further agree to allow Club Management and/or its Representatives, at their sole discretion, to verify the accuracy of all information to their satisfaction, up to and including requiring the Applicant to provide permissible proof of any declaration. If any declaration by the Applicant is determined by OVGC Management to be inaccurate either during the membership approval process or, if approved, at any time during the membership term, OVGC Management reserves the right to immediately terminate the Applicant's membership and require, in accordance with established Club Rule and Policies governing memberships, full payment of all financial obligations owed to the Club.
