TERMS AND CONDITIONS

- 1. <u>Term of Annual Pass</u>. The Annual Pass shall commence upon the execution of this Annual Pass Application or the date on which Club Operator approves and accepts guests application, as set forth below, and shall continue in effect until terminated by Club in the event of Annual Passholders violation of the rules and regulations of the Club or Annual Passholders breach of the terms and conditions contained herein. Membership and all benefits from membership expire 12/31/2026.
- 2. <u>Annual Pass Fees</u>. Guest understands that the Annual Pass is subject to payment fees set forth above. <u>Annual Pass fees are non-refundable and/or non-transferable</u> and are subject to change without notice. Golf Course operator reserves the right to limit pass sales as it deems necessary.
- 3. <u>Receipt of Club Documents</u>. By execution below, Guest acknowledges receipt of the Annual Pass Rules and Regulations, and agrees to be bound by and comply fully with the terms and provisions of such documents, as they may be amended.
- 4. <u>Assumption of Risks and Indemnification</u>. In consideration for the privilege of using the Club Facilities, each person entering upon or using the Club Facilities agrees:
 - (a) to accept all risks associated with the use of the Club Facilities and to release the Club, its employees, agents, officers, Directors, Successors, and Assigns from and indemnify and defend the Club against any and all claims, whether or not based on the acts or omissions of the Club, arising out of or in any way connected with such use of the Club Facilities; and
 - (b) to assume sole responsibility for their personal safety and the safety of their personal property brought upon, used or stored at the Club Facilities; the Club shall not be responsible for any loss or damage to any personal property brought upon, used or stored at the Club Facilities, whether in lockers or elsewhere.
 - (c) Each Annual Passholder further agrees to be responsible and liable for any property damage and/or personal injury which such Annual Passholder causes, or which is caused by such Annual Passholders authorized guests, while on the Club Facilities, or at any activity or function operated, organized, arranged or sponsored by the Club. In addition, a Annual Passholder who arranges or sponsors any activity or function at the Club Facilities shall be responsible for any such damage or injury even if such damage or injury was not caused by the Annual Passholder.
- 5. <u>No Vested Interest</u>. No guest or any other person or entity shall have any ownership or proprietary interest, beneficial interest in the Club, Club Facilities, or any of the assets of the Club.
