ANNUAL PASS AGREEMENT TERMS AND CONDITIONS

PAYMENT – The annual pass dues must be paid in full to commence use of program.

 $REFUSAL\ OF\ PRIVILEGE-Falmouth\ Country\ Club\ shall\ have\ the\ right\ to\ refuse\ golf\ course\ privileges\ to\ anyone\ who\ is\ judged\ to\ be\ in\ violation\ of\ the\ established\ rules\ and\ regulations\ herein.$

REGISTRATION - All Golf players must register and sign in at the Golf Shop before play. Annual Pass Holders are required to show their Annual Pass Card (which is non-transferable). Golf play starts from the first tee unless advised otherwise by the Golf Shop.

HOLIDAYS - Falmouth Country Club recognizes the following holidays: Memorial Day, Independence Day, Labor Day. Weekend rates apply to these days.

GOLF STARTING TIMES - Starting times may be obtained by via the Internet at www.falmouthcountryclub.com or by calling the Golf Shop at 508.548.3211. These are available up to 14 days in advance and are recommended so we may avoid any inconvenience on the day of play. In order to provide the maximum tee time availability to all annual pass holders, please extend the courtesy and call the Golf Shop if you are not going to use a reserved tee time. Annual Pass Holders without reserved times will be subject to availability.

TEE TIME RESERVATIONS - Cancellation Policy - Each Annual Pass Holder has the capability of reserving tee times up to 14 days in advance. Falmouth Country Club reserves the right to pair all twosomes and threesomes. When reserving tee times, Annual Pass Holders are responsible for the number of players booked. *NO CALLNO SHOW* - Annual Pass Holders are responsible for 100% of any tee times booked and not cancelled prior to 24 hours in advance. Annual Pass Holders who do not show for their tee time, or without all the players reserved for the tee time, will be charged the full rate for each player not showing to the Pass Holder's credit card that is stored under their annual pass profile in the point-of-sales system. Annual Pass Holders are responsible for calling the Golf Shop with any changes to tee times. Groups that habitually no-show will be subject to member suspension. No groups are permitted to have more than four players per tee time.

DRESS CODE - Golfers are expected to wear traditional golf attire on the course. Falmouth Country Club is a non-metal spike facility.

PACE OF PLAY - All Annual Pass Holders are expected to abide by the pace of play policies instituted by the General Manager. Players are expected to play in 4 hours and 30 minutes or less. (Pace of Play Policy is enclosed.)

COURTEOUS PLAY - It is golfing etiquette to replace divots, repair ball marks on greens, rake smooth all marks made in sand traps and remove used tees from the teeing grounds. Please assist us in the upkeep of the course and encourage your guests to do likewise.

GOLF CARTS - Cart rules will be posted daily on the first tee and all players are expected to abide by these rules. Carts must be driven on cart paths only on all Par 3's and kept at least 20 feet from all Tees and Greens at all times. Roped off areas are off limits to carts. Players must pair up on carts. No single carts will be permitted in twosome or foursomes.

USGA GHIN HANDICAP - All Falmouth Country Club Annual Pass Holders are eligible for a handicap. See a member of our professional staff to setup your GHIN handicap. Players that do not enter all scores will be ineligible to compete in Annual Pass Holder tournaments and events.

FOOD & BEVERAGE – Liquor and alcoholic beverages are not permitted on the course unless purchased from Falmouth Country Club. Snack Bar items may be purchased from the Golf Shop or the beverage cart on the golf course. Private coolers are not permitted. Players will be refused play and the privileges will be lost if any policies stated herein are not adhered to.
