2024 Orchard Valley Golf Club Annual Pass Agreement

Eligibility

At the discretion of Orchard Valley (the "Club"), the annual passes are available without discriminatory regard to race, gender, creed, religion, or national origin. Prospective passholders must complete an application and acknowledge all terms, policies and conditions contained herein. Club reserves the right to cancel or amend this offer at any time without notice.

Terms & Renewal

Unlimited golf privileges associated with the annual pass is valid through 12/31/2024 – All passholders are <u>required</u> to have a credit card on file with the Club. Unlimited golf privileges outlined in the annual pass agreement do not extend to tournament play, special events, or outside league play. All guests shall pay the current rates. Passholders will receive the following benefits:

- (2) small buckets of range balls per day (equivalent to (1) medium bucket).
- Golf Shop 20% off Soft Goods, 10% off Hard Goods.
- Food & Beverage 10% off all food & beverage items, excluding alcohol.
- All passholders will receive \$100 in Credit Book upon signup.
- Register before 12/31/23 and receive \$100 in Credit Book and a \$100 gift card to be used towards Fox Valley Park District programming and events. Register before 3/1/24 and receive \$100 in Credit Book. Credit Book may only be used on Food & Beverage or Merchandise from the Golf Shop.

Reservations, & Cancellations, Check-In

Tee times may be reserved up to thirty (30) days in advance. Any tee times that are not cancelled within the standard 24-Hour window will be charged the applicable rate.

To maintain the integrity of play administration, all passholders are required to make a tee time and MUST CHECK-IN the golf shop prior to beginning play. All play will begin on hole #1.

Pace of Play

Players are required to always keep pace with the group in front of them and/or complete 18 Holes at a pace of 4 hours and 20 minutes.

Golf Cart Policy

Golf Cart is included with the annual pass, unless otherwise noted. The Club reserves the right to modify daily cart rules/restrictions as deemed appropriate and without warning. Passholders are financially responsible for any damages incurred during their round.

Course Availability

The Club reserves the right to host outside events that will limit course availability throughout the year. In most cases, the ClubGolf Shop can inform you of these instances up to 30 days in advance.

Dress Code

The Club is a non-metal spike facility. Men must wear shirts with a collar and sleeves at all times. Ladies may wear a polo with collar and or sleeves. T-shirts, tank-tops, halter-tops, and swimwear are not allowed at any time. Denim is also not permitted at the Club, except during winter and shoulder (March, April, September, October, November) months.

Transfers & Revocations

The privileges provided to the passholder are individual, and may not be sold, transferred, or assigned in any manner. Any fees paid are non-refundable. The Club reserves the right immediately revoke membership and its' privileges if a card holder is found to have violated the terms herein.

Policies and procedures are established and administered by the Club and its employees. Passholder in no way conveys rights of ownership and its privileges outlined in this document are subject to change at any time by the Club in its sole discretion.

The Undersigned hereby agrees that the information contained within this document is completely accurate and further agree to allow the Club, at its sole discretion, to verify the accuracy of all information to their satisfaction, up to and including requiring the applicant to provide permissible proof of any declaration. If any declaration by the applicant is determined by the Club to be inaccurate either during the passholder approval process or, if approved, at any time during the passholder term, the Club reserves the right to immediately terminate the passholder's status.
