Membership Terms and Agreement

PAYMENT – The membership dues must be paid in full to commence use of the program. Payment must be made in person in the Golf Shop or by mail. Please make checks payable to Dauphin Highlands. Couples defined as individuals who share a residence.

REFUSAL OF PRIVILEGE — Dauphin Highlands shall have the right to refuse golf course privileges to anyone who is judged to be in violation of the established rules and regulations herein.

REGISTRATION — All golfers must register and sign in at the golf shop before play. Members are required to show their Membership Card (which is non-transferable). Cart not included unless Cart Pass is purchased.

HOLIDAYS - Dauphin Highlands recognizes the following holidays: Memorial Day, Independence Day, Labor Day, Thanksgiving. Weekend rates apply to these days.

GOLF STARTING TIMES — Starting times may be obtained via the internet at www.golfdauphinhighlands.com or by calling the golf shop at 717.986.1984.

TEE TIME RESERVATIONS - Cancellation Policy - Each Membership Holder has the capability of reserving tee times up to 15 days in advance. Dauphin Highlands reserves the right to pair all twosomes and three-somes. When reserving tee times, Membership Holders are responsible for the number of players booked. Dauphin Highlands has implemented a 24-hour cancellation policy. Membership Holders are responsible for calling the Golf Shop with any changes to tee times. Membership Holders who short show or no show will be subject to a no show charge for each player. Groups that habitually no-show will be subject to member suspension. No groups are permitted to have more than four players per tee time. Member rate not valid for pre-booked outings or events. Golf Shop discount on regularly priced merchandise only.

DRESS CODE - Golfers are expected to wear traditional golf attire on the course. Dauphin Highlands is a non-metal spike facility.

PACE OF PLAY - All Membership Holders are expected to abide by the pace of play policies instituted by the Dauphin Highlands Management. Players are expected to play in 4 hours and 30 minutes or less. (See separate Pace of Play Policy.)

COURTEOUS PLAY - It is golfing etiquette to replace divots, repair ball marks on greens, rake smooth all marks made in sand traps and remove used tees from the teeing grounds. Please assist us in the upkeep of the course and encourage your guests to do likewise.

GOLF CARTS - Cart rules will be posted daily in the Golf Shop and all players are expected to abide by these rules. Carts must be driven on cart paths only on all Par 3's and kept at least 30 feet from all Tees and Greens at all times. Roped off areas are off limits to carts. Players must pair up on carts. No single carts will be permitted in twosome or foursomes.

USGA GHIN HANDICAP - All Dauphin Highlands Membership Holders are eligible for a handicap. See a member of our professional staff to setup your GHIN handicap. Players that do not enter all scores will be ineligible to compete in Membership Holder tournaments and events.

FOOD & BEVERAGE — Food and beverages are not permitted on the course unless purchased from Dauphin Highlands. Snack Bar items may be purchased from the Golf Shop or the beverage cart on the golf course. Private coolers are not permitted. Players will be refused play and the privileges will be lost if any policies stated herein are not adhered to.

LIMITATION OF LIABILITY — Dauphin Highlands will not be liable for any lost profits or for any indirect, incidental, consequential, punitive or other special damages suffered by the player arising out of or related to this Agreement even if Dauphin Highlands has been advised of the possibility of such damages. In no event shall the total cumulative liability of Dauphin Highlands in connection with the Agreement from all causes of action of any kind (including tort, contract negligence, strict liability, breach warranty and fundamental breach) exceed the total amount paid by the player to Dauphin Highlands under this Agreement.
