- The following is not permitted on DISC GOLF Course at Enger Park during peak period, April 1st thru October 31st. Please adhere to the Enger Park & City of Duluth Park's District Rules.
 - No outside beverages or food maybe brought onto the golf course or parking lot during peak period.
 - No pets are permitted on the golf course during peak period.
 - All groups must play with 4 players or less. Permission maybe granted from the pro shop for 5 players during slower times. The size of your group is 5 or less only during peak period.
 - Access to the DISC GOLF course during peak period is 1 hour after sun rise until 10 PM each day.
 - All rounds during off peak & peak hours must be checked in. Off peak please drop note in the drop box and pay all guest fees of \$5. Between April 1st and October 31st please check into club house for all rounds.
 - Golf course superintendent may have Enger Park Golf Course closed occasionally due to un safe or possible damage to turf conditions. Examples are frost, extremely wet conditions, etc.

TERMS AND CONDITIONS

1. Term of Annual Pass. The Annual Pass shall commence upon the execution of this Application or the date on which Duluth Golf approves and accepts Application, as set forth below, and shall continue in effect until terminated by: (i) Guest completing and submitting a Cancellation form; (ii) by Duluth Golf in the event of Guest’s violation of the rules and regulations or Guest’s breach of the terms and conditions contained herein. Annual Pass and all benefits from program expire 12/31/2021.

2. Annual Pass Fees. Guest understands that the Annual Pass is subject to payment fees set forth above. Annual Pass fees are non-refundable and/or non-transferable and are subject to change without notice.

3. Receipt of Club Documents. By execution below, Guest acknowledges receipt of the Duluth Golf Rules and Regulations, and agrees to be bound by and comply fully with the terms and provisions of such documents, as they may be amended.

4. Assumption of Risks and Indemnification. In consideration for the privilege of using the Facilities, each person entering upon or using the Facilities agrees:

- (a) to accept all risks associated with the use of the Facilities and to release Duluth Golf, its employees, agents, officers, Directors, Successors, and Assigns from and indemnify and defend Duluth Golf against any and all claims, whether or not based on the acts or omissions of Duluth Golf, arising out of or in any way connected with such use of the Facilities; and
- (b) to assume sole responsibility for their personal safety and the safety of their personal property brought upon, used or stored at the Facilities; Duluth Golf shall not be responsible for any loss or damage to any personal property brought upon, used or stored at the Facilities, whether in lockers or elsewhere.
- (c) Each Guest and Guest's designee further agrees to be responsible and liable for any property damage and/or personal injury which such Guest or designee causes, or which is caused by such Guest’s or designee’s authorized users or guests, while on the Facilities, or at any activity or function operated, organized, arranged or sponsored by Duluth Golf. In addition, a Guest who arranges or sponsors any activity or function at the Facilities shall be responsible for any such damage or injury even if such damage or injury was not caused by the Guest.

5. No Vested Interest. No Guest or any other person or entity shall have any ownership or proprietary interest, beneficial interest in the Facilities, or any of the assets of Duluth Club.
